On Friday, December 20th, 2019, I was assigned to uniformed patrol in marked cruiser number 94, sector two. At approximately 1541 hours I was dispatched along with Sgt. Parker to the area of Hunt Club Way and Prescott Street for the report of 3-4 dogs attacking another dog. Dispatch advised that two of the dogs possibly have dog coats on.

We checked the area and were not able to locate any loose dogs. The Animal Control Officer (ACO) Mary Letourneau and the Animal Inspector, Robin Hebert were both contacted. Mary stated that she would respond. I met up with Mary and she was speaking with Meghan Bourque-Tyler by cell phone. Mary advised me that a German short haired pointer that lives at 4 Hunt Club way was attacked in it's front yard and was currently at the Veterinarian 's in surgery for it's injuries. Mary stated the dogs involved with the attack were a large white/blond colored Shepard, medium size reddish colored dog and a small black dog. Mary stated that Meghan has dogs that fit that description but when Mary spoke with Meghan she said her dogs were inside the house.

I responded back to 4 Hunt Club Way to speak with the owner of the attacked dog, Joseph Ford. Joe stated that he was down at the barn with his girlfriend tending to the horses when he heard the dog's fighting. Joe stated that he ran back up to his house to see the Shepard and the reddish colored dog attacking his. Joe thought the reddish colored dog had a reddish/plaid colored dog coat on. Joe stated that he pulled the reddish colored dog off of his and the dogs ran off. Joe stated that his dog was badly injured. Joe had blood all over his clothing and showed me pictures where the dog attack occurred and all the blood in the snow and on the walkway. Joe stated that his dog was currently in surgery for a very bad wound to it's right shoulder.

Joe stated that he came home and followed the dog tracks and they led back to Meghan and Ryan Tyler's home. Joe stated that he was taking pictures of the dog prints when Ryan came out to him. Joe asked if he owned any dogs that fit the description of the ones that attacked his dog and he stated that he did. He said the black dog was a black Lab and not small though. Joe stated that Ryan admitted to having issues with the Sheppard. I contacted Mary and asked her to respond to Joe's house.

Mary arrived and spoke with Joe and took down his information. Mary and I then went down to speak with Meghan and Ryan. Meghan brought us inside the house to see the dogs. Meghan stated the dogs were inside the house and that they didn't own a dog coat like the one Joe described. Mary inspected the dogs and couldn't see/find any indication that the Sheppard and the reddish colored dog were in a fight. Mary advised me that she would call and speak with Joe.

I called and spoke with Joe who stated that he hadn't heard from Mary. I advised him that Mary couldn't find any marks or indication that Ryan and Meghan's dog's were the ones involved. Joe stated that he viewed a picture of Ryan and Meghan's dogs online and was 100% positive all three of their dogs were the ones involved in the attack on his dog.
