Subject: Tylers/Dog Hearing

To whom it may concern,

Good morning my name is Justin Rollins and I am a past client of the Tyler's/Bourque's. I was at the hearing on Monday night but was unsure if I could speak as I am under 18.

I just wanted to reach out and add that when Meghan Bourque mentioned that she would never leave her child alone with the dogs is a complete lie.

Around April/May of 2017 when I was still working for the Tyler's a rider had fallen off of a horse and I had called Meghan to let her know and she came running to the lower barn from the house. She did not have the dogs or her child with her. After about 5-10 minutes of Meghan being down at the barn she had asked me to go up to the house because she had left the baby in the house, I ran up to the house and the baby was laying on the floor, alone with all 3 dogs (cream colored Shepard, black lab like dog, and a red hound mix) in the room with him. Ryan Tyler had taken the truck off property and was not in the house at the time. Therefore the child was left unsupervised with the dogs in the same room as him. After about 15 minutes Ryan had returned to the house and him and I took the baby down to the barn and he had left the dogs loose in the house, not locked behind "two deadbolt doors".

I would also like to add the MSPCA and state reports from the barn. They do not care for their animals. When I was friendly with them and would be at the farm I would observe that many of their animals (cats, dogs, horses, chickens, and bunnies) would be left with no food or water/dirty water. They do not know proper care for their animals. Robin and Mary are friendly with the Tyler/Bourque family and many times over look issues and just mention that its an issue and does not report/record it and then nothing is done. When I kept my horse at the property and Robin would show up to do a barn check she would always text or call before. As I worked for them I saw the abuse and neglect of all the animals on their property. I will attach a copy of reports and a copy of my email to the state with photos showing lack of care and text screenshots showing lies and not having food for animals.

As a victim of their manipulation and lies I want to see something done about these matters. They starved many animals. The dogs were very thin when I knew them and always loose on property. When they were not loose they were locked in a tiny "kennel" with no toys, food, and most the time no water, when there was water it was gross. They do not have the ability to care for any of the animals on the property.

This past summer NEER North Eastern Equine Rescue came in and took about 4-5 horses out of their care. That showing that they can not care for animals and should be shut down. Also Ryan is not a licensed equine riding instructor but was teaching lessons to me. Ryan also is a self proclaimed farrier and has made many horses lame from putting shoes on incorrectly, my own horse included.
