North Andover, Massachusetts

To the Board of Selectmen  
Of Pepperell, Massachusetts

Massachusetts Electric Company d/b/a National Grid and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Lowell Road - National Grid to install 1 JO Pole on Lowell Road and remove 1 JO Pole on Lowell St beginning at a point approximately 0 feet north of the centerline of the intersection of Lowell St Tarbell St, and Lowell Rd. Relocating existing pole 15-50 +/- 30ft east of current location from Lowell St to Lowell Rd.

Location approximately as shown on plan attached

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked – Lowell Rd - Pepperell - Massachusetts.

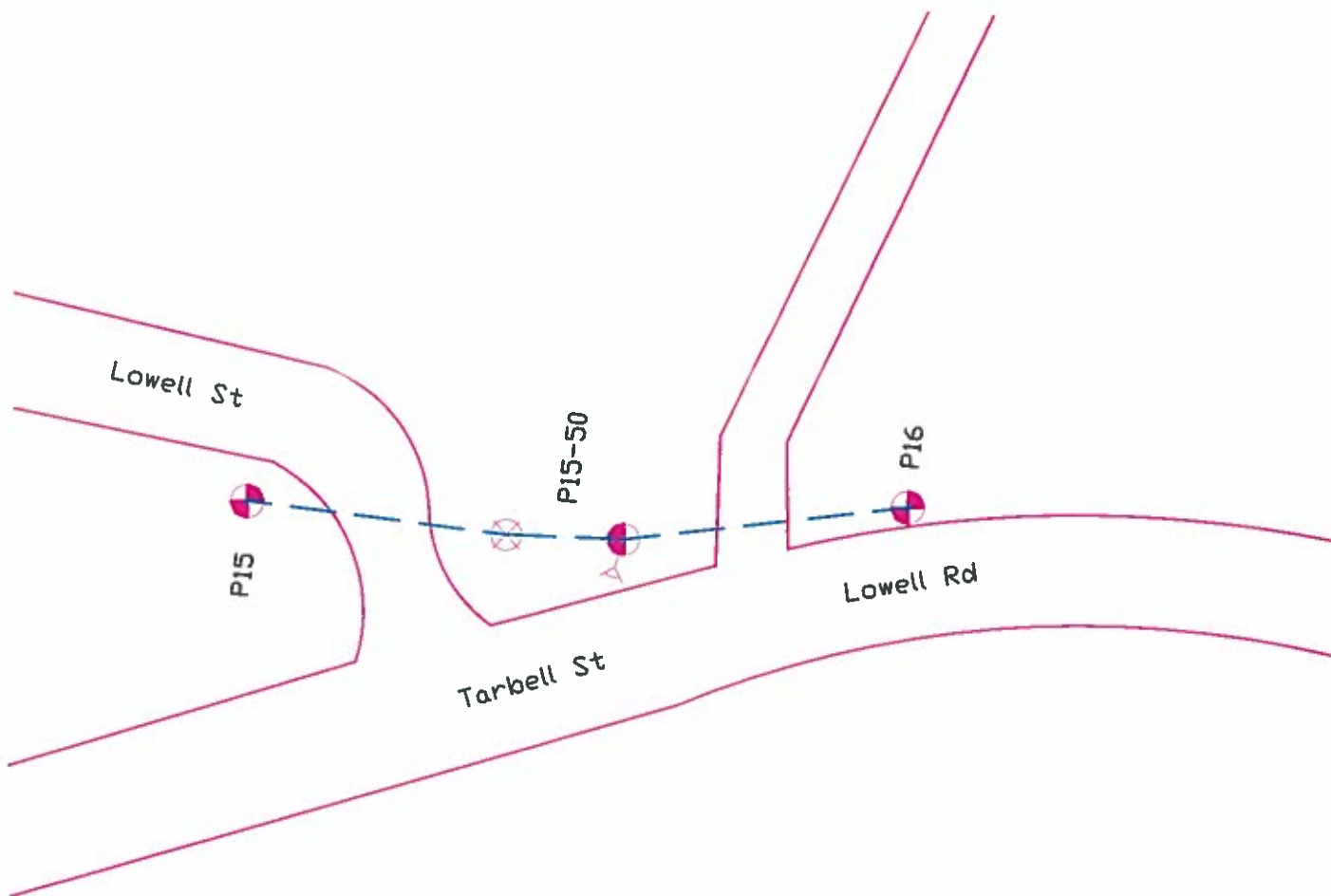
